Utah's Shawna Cuan Presented 2016 ESC Public Sector Leadership Award

During the closing ceremonies of the 2016 ESC Market Transformation Conference in Louisville, Shawna Cuan of the Utah ESC Chapter, was awarded the 2016 ESC Public Sector Leadership Award.

The ESC Chapter in Utah was reinstated at a meeting of steering committee members on February 17, 2016. What Success Looks Like: Utah-Style

September 4, 2016 * City of Orem will save an estimated \$11.4 million in energy and operational cost savings and capital cost avoidance over 15 years as a result of its new GESPC. Energy efficiency measures include upgrading the city's 5,182 streetlights with LED bulbs, resulting in a projected annual savings of \$181,000. The project scope also included energy retrofits improvements at the city center, public library, public safety building, senior center, recreation center, and citywide fire stations.
