## North Carolina named Energy Stewardship Champion

The ESC announced its 2017 Energy
Stewardship Champion awards in recognition of
outstanding accomplishments in leveraging
Guaranteed Energy Savings Performance
Contracting (GESPC) to achieve energy
savings, infrastructure modernization,
environmental stewardship, and economic
development.

North Carolina was among 12 state Champions recognized for this annual award during the closing ceremonies at the ESC's Market Transformation Conference in Henderson, Nevada on Friday, August 11th.

To date, over 75 public jurisdictions throughout North Carolina have executed guaranteed energy savings performance contracts, leveraging more than \$500 million in private sector investments into an estimated \$50 million in guaranteed annual energy cost savings.

**July 12, 2017** \* The North Carolina Department of Transportation is replacing existing highway lighting statewide with energy-efficient LEDs as part of a massive GESPC project with a \$32.3

million price tag. The contract covers 15 years with a guaranteed savings of more than \$50 million in electrical and operational costs. Brady Trane is undertaking the construction which is targeted for completion in November 2018. Costs will be financed through Bank of America under a 2.1 percent interest rate.

January 31, 2017 \* Improvements intended to reduce energy costs at Robeson Community College and free up dollars to be used for other purposes are about to get underway. The college has entered into a guaranteed energy performance contract to make upgrades in all the buildings on the college's main campus in Lumberton and at COMtech in Pembroke. The college borrowed \$2.9 million from Bank of America to pay for the work, locking in a 2.17 percent interest rate on the 15-year loan. Before the college could enter into the performance contract, the Robeson County Board of Commissioners had to pass a resolution stating that the board would not reduce over the life of the contract the money that the county allocates to RCC to help pay its energy costs.

January 25, 2017 \* The Brunswick County Board of Education's Operations Committee has agreed to a 20-year guaranteed energy savings performance contract and a third-party engineering services contract to oversee the process. The total cost of the project ranges from \$15-million to \$17-million, with estimated savings of \$24-million.
